LIBRARY

Vivek has a good automated library having a collection of more than 8000 books and 14 periodicals/journals. It is situated in the first floor of the college building. It has a collection of Books, Reference Books, Maps, Periodicals, Reports etc. Every year, the collection is strengthened by adding new publications. The library subscribes 5 Newspapers. The library maintains a separate textbook collection. In the textbook section, the library has maintained a Question Paper Collection for the benefit of the students. It also provides important General Knowledge and other reference books for the preparation for competitive examinations. Our reference section is rich with standard encyclopedia, dictionaries in different languages, Handbooks, Year books etc. The students are issued a Library Card by which the students can borrow books from the library.

NEWSPAPER CLIPPING SERVICE

The library maintains important newspaper clippings collected from the newspaper subscribed to in the library for the benefits of its students.

WORKING HOURS OF LIBRARY

The library is open for users from 10.00 a.m. to 5.00 p.m. on all working days and 10 30 a.m. to 1.30 p.m. on Saturdays.

LIBRARY RULES AND REGULATIONS:

1. Every student has to produce his/her identity card with his/her photograph firmly attached to it and attested by the Principal to get the library card issued. The identity card should be shown whenever demanded.
2. Books are issued from the Library exclusively for students. Library facility will be denied to anyone found applying for books for others.
3. It is the responsibility of the student to examine a book carefully when he/she receives it and report to the librarian if any damage is found there in. Failure to do so makes the student responsible for any damage detected later.
4. If a book is lost or damaged, its cost must be paid by the reader in whose name it was issued. The value of the book will be assessed by the librarian.
5. A book is generally issued for a period of 7 days. When there is a great demand, it may be issued for less number of days. No book will be issued for more than two weeks.
6. A fine of Rs. 1/- per book per day (including Sundays and Public holidays) will be levied on all books retained without renewal by a reader beyond the due date. Repeated failure on this score may lead to cancellation of library membership. Fine may be increased during the examination period.
7. The Librarian reserves the right to recall any book or periodical at any time.
8. All books borrowed are to be returned before claiming caution money.
9. Complete silence is to be observed in the library.
10. Smoking or eating is strictly forbidden in the library.
11. No electronic gadgets are allowed in the library. Viz. Music system, Radio, Mobile Phone, Tablets etc.
12. Access to the library can be prohibited on grounds of misbehaviour, indiscipline or disregard to library rules.



SCHOLARSHIPS AWARDED BY THE COLLEGE

Scholarships are awarded by the College strictly on the basis of merit at the last annual examination plus having passed in all the college examinations during the current academic year i.e. Terminal and Preliminary Examination, failing which scholarship will be cancelled and awarded to the next student as per merit.

3. Shri. S.S. Shankar Memorial Prize: Awarded by Shri. Subramanyam S. Iyer in memory of his father, late Shri S.S Shankar to a deserving student of Vivek Vidyalaya studying in F.Y.J.C of Vivek Vidyalaya Junior College.
4. Dr. R. G Krishnan's Cash Prize: Awarded by Dr. R.G. Krishnan to the student who stands first in Junior College, SYJC.
5. Vivek Education Society's Cash Prize: Awarded to the students who secure State Rank List in the H.S.C Examination.
6. Vivek Education Society's Cash Prize: Awarded to the students who secure State Merit Prize in any subject in the H.S.C Examination.
7. Vivek Education Society's Cash Prize: Awarded to the students who secure highest marks in the H.S.C Examination stream wise (Arts, Science, Commerce).

COLLEGE RULES

- As soon as a student is given admission he/she will be charged full fees for both the terms.
- Every student will receive, on admission a valid identity card Which will have passport size photo of student affixed in the space provided bearing the Principal's signature. It is mandatory to wear the Identity Card for entry into the campus and should be worn at all times within the college premises.
- Students must attend lectures, practicals and tutorials according to the time-table of their respective classes on all days when the college is working. They must appear for all the college examinations. Absence from any of these or unsatisfactory performance will lead to loss of terms and detention. Every student has to complete the course of study prescribed for the examination for which he/she is studying including tutorials to the satisfaction of the Principal. A minimum attendance of 75% in each term is required from the student, failing which strict action will be enforced the student may be detained.
- A day's attendance means attendance during all lectures, tutorials and practicals, according to the class timetable for the day and not any one of them.
- Students shall not attend classes other than their own without prior permission of the teachers concerned.
- Students must behave properly, both inside the classroom and in the college premises and must not do anything that may cause disturbance to any class or to their fellow students. Loitering in the corridors is strictly prohibited. Severe action will be taken for the lapse.
- Students must not gather around or near college premises.
- Smoking is strictly prohibited in any part of the College building including the canteen. Students found smoking in the premises may be fined Rs.500/-.
- Students must not do anything inside or outside the college that will in any way interfere with its orderly administration, discipline and smooth functioning.

- No society must be formed, no meeting to be held and no one to be invited to address the students in the college without prior permission from the Principal.
- In college debates and other meetings, the chair must be taken by a responsible person approved by the Principal and the subject of debates or lectures must have the prior approval of the Principal.
- Students are not authorized to communicate any information or write to the press about the matters dealing with the College administration.
- Students are expected to take proper care of the College property and to co-operate in keeping the premises neat and tidy. Any damage to the college building or property by disfiguring walls, doors or breaking furniture, apparatus, fitting etc. is a breach of conduct.
- If, for any reason the continuance of a student in the college in the opinion of Principal detrimental to the best interests or discipline of the college, she may direct such a student to leave the college without assigning any reason for her decision which shall be final.
- Students receiving Government or College Scholarship or any remission in fees must note that the grant and continuance thereof subject to good behaviour, attendance, satisfactory progress and good results at the College and Board examinations.

IMPORTANT

1. Students are not permitted to use mobile phones within the college premises. Any student found with mobile phones within College/Library/Canteen, the mobile phone will be confiscated and/or fined.
2. The College follows certain dress code, by which students are not allowed to wear sleeveless dresses, tight tops, short tops, miniskirts, caps, low waist jeans/pants, unbuttoned shirts etc. in the College premises, Students are expected to come to the College well dressed.
3. Student should not do anything that may lower the prestige of the institution. They should consider themselves as a part and parcel of the college and strive to do things which would elevate the dignity of their Alma Mater. They should develop the college spirit. The essence of this spirit is that they should conduct themselves properly while dealing with their fellow students, teachers, the college staff and public.
4. All the students should strive to work honestly for the emotional integration of the motherland. They are expected to play their part in curbing all those tendencies which lead to disintegration of the country, such as communalism, regionalism, linguism and parochial outlook.
5. Matters not covered by the above rules will rest at the absolute discretion of the Principal.

RULES FOR ADMISSION

Admission to all the seats will be done through ONLINE .

Applications for admission to F.Y.J.C must be complete in all respects and accompanied by a copy of (i) The Mark Sheet (ii) School Leaving Certificate and (iii) Eligibility Certificate Application Form (if required). The form must be signed by the student and the parent/guardian.

After a student is selected for admission he/she will have to submit the following documents at time of admission

- (a) 2 copies of Mark sheet
- (b) Original School Leaving Certificate from the School last attended by the student along with 2 copies of the same.
- (c) For claiming Girls' freeship/BC freeship/ EBC freeship, Photocopies of the Ration card (first and last page where the student's name appears) and Photocopies of any document showing 15 years of domicile of parents in Maharashtra must be submitted.
- (d) For I.C.S.E / C.B.S.E / Other State Boards / Out of India students should submit Migration certificate and Photo copies of the same and Eligibility Application form from Mumbai Divisional Board.
- (e) Students are advised to keep sufficient number of Photo copies of the certificates.
- (f) The students must affix recent photo on the admission form and have 3 more copies of photo with him/her for identity card and other purposes.

The student should be present himself/herself at the time of admission and accompanied by the parent/guardian. (NOT APPLICABLE FOR ONLINE ADMISSION PROCESS)

Admission will be confirmed only after the fees are paid in full.

GUIDELINES FOR ADMISSION FOR STUDENTS IN VIVEK VIDYALAYA JUNIOR COLLEGE

The Criteria of admission to Vivek Vidyalaya Junior College will be governed by the judgements, determined by the Mumbai High Court as Minority Educational Institutes, as per the judgement of the Hon'ble Supreme Court of India.

(A) Therefore while deciding the merit, college will consider;

Performance at the last examination and also previous record.

Performance in extra - curricular activities like cultural activities, sports at State and National level, N.C.C, N.S.S.

(B) 50 % of the total number of seats will be reserved for Tamil/Malayalam speaking students.

(C) 10% of total number of seats will be reserved for the In-house students i.e. the students from Vivek Vidyalaya.

(D) The Principal is empowered to refuse the admission of any student even if he/she has merit otherwise, if the Principal doubts his/her character, or due to various reasons.

Every care has been taken to ensure transparency and objectivity on admission process. College is striving hard to impart the best quality of education and produce citizens of National character, Discipline and Integrity with the highest proficiency in their profession. The college following the guidelines of Vivek Education Society, reserves the right to manage and administer working of Vivek Vidyalaya Junior College in accordance with the Article 30(1) of constitution of India with the sole object of achieving academic excellence.

FINAL EXAMINATION

There will be no board examination at the end of the FYJC. The annual examination at the end of the FYJC will be an internal examination. There will be Board examination (Higher Secondary Certificate Examination) at the end of the SYJC. This examination will be held under the auspices of the Mumbai Divisional Board of Secondary and Higher Secondary Education, Pune.

SOME RULES OF PROMOTION AT THE F.Y.J.C ANNUAL EXAMINATION

- Minimum marks for passing in a subject will be 35%.
- There shall be no provision of A.T.K.T.
- In a subject for which there are two papers or one paper and one practical test, the marks will be added together for a pass, credit of distinction.
- The result of the FYJC class will not be decided on the marks obtained only in the annual examination. According to the new rules of evaluation equal weightage will be given to (a) Terminal examination (b) Annual Examination and (c) Year's work, practicals, Unit tests, tutorials etc., and the final result of the student will be decided on the average marks $[a+b+c]/2$
- There shall not be re-examination in the case of students who have failed.
- Candidates who have failed at the FYJC examination shall have option to claim exemption in the subject/s in which they have secured minimum passing marks previously.
- Students failing at the examination of the F.Y.J.C are permitted to appear externally for F.Y.J.C examination in the next October/March or thereafter. However, the question papers to such students shall be on the entire portion prescribed in the syllabus for FYJC for the subject/s concerned.

- If a candidate appears in all subjects and fails in one or more subjects, his/her deficiency of marks in maximum three subjects to a maximum of 30 marks in the aggregate but not exceeding 10 marks in any one subject shall be allowed and shall be limited to 3 subjects only out of the subjects offered.
- No grace mark will be given in Environmental Studies.
- The candidate appearing with exemption under regulation 38 will not be entitled to the benefit of condonation of marks.
- In case of students of FYJC who could not appear at the first terminal examination for genuine reasons due to ill health(on production of medical Certificate) or such other reasons beyond their control, the head of the Junior College shall hold terminal examination by setting a different question paper as early as possible but in any case before the end of 2nd term on the dates according to the convenience of the college. The same applies for annual examination. There shall be no extra fees for re-examination. However no medical certificate will be accepted for absence from Unit Test. If a candidate fails to appear for the terminal examination arranged at the second time, his/her result at the annual examination shall be decided on the average marks.
- If a student does not submit his/her EVS project on prescribed date, he/she will not be eligible for promotion.
- Strict action will be taken against students using unfair means during the examination. They may even stand to lose a year.
- 75% Attendance separately in lectures and practical in each term is compulsory.

ADMISSION TO THE EXAMINATION HALL (R-96)

- a) Every candidate to the Higher Secondary Certificate Examination shall be given an Admission Card by the Divisional Board and the candidate shall be required to produce it every day of the Examination to the conductor of the Examination at the Centre where he/she appears for the examination.
 - b) The Admission Card shall be issued to the candidate on behalf of the Divisional Board by the Head of the Junior College and Signed by the candidate in the presence of Head of Junior College.
 - c) If for any reason, the candidate fails to produce such Admission Card or the Admission Card produced does not bear the candidate's signature attested by the Head of the Junior College, the Conductor may allow the candidate to appear for the examination only after satisfying himself as to the candidate's identity by making enquiries to corroborate the information available to him from the list of candidates.
 - d) The Conductor shall issue a permit signed by him/her for presenting it by the candidate on subsequent days of the examination.
 - e) In case, where the candidate's signature if taken in the Examination Hall, does not tally with that on the Admission Card, the candidate shall be liable to be refused permission to appear for the Examination.
 - f) A minimum of 75% attendance separately for each term is mandatory for eligible to appear for both FYJC and SYJC examinations.
- No Candidate shall be admitted to the Examination Hall if he/she arrives late by more than half an hour after the commencement of the examination.
 - Candidate suffering from any infection or contagious disease shall not be admitted to the Examination Hall. If any such case comes to the notice of the Conductor of the Examination, he/she will make separate arrangements for that candidate's seating.

Every F.Y.J.C / S.Y.J.C student must attend the prescribed number of tutorial periods shown in the time-table failing which the students will not be graded.

Every F.Y.J.C / S.Y.J.C student must complete the project work given in any subject as per the requirements of the syllabus.

The promotion of students from FYJC to SYJC will be decided as per Government Regulations on basis of minimum 75% attendance in Lectures/ Practical's and Tutorials and the average performance of all the Unit Tests, Practical Test, Terminal Semester Test and Annual Examination. Every student is required to take a note of this.

COLLEGE TERMS AND TENTATIVE EXAMINATION DATES




